

Declaration & Authorisations & Terms and Conditions, Chubb in Viet Nam



We hereby declare and agree that:

1. All written information provided by Me/Us in this application, (Passenger & Payment Page), or any formal questionnaire or other confirmation signed by Me/Us in conjunction with this application, and statements and answers made to Chubb Insurance Viet Nam Company Limited (“Chubb”) are complete, true and correct, and I/We understand and agree that Chubb, believing them to be such, will rely and act on them, otherwise any policy issued or coverage granted by Chubb may be void at its option.
2. This application is not a contract of insurance. No insurance is in force until this application is accepted by Chubb. However, my declarations or disclosures shall form the basis of the contract of insurance.
3. Once the insurance is activated, it is non-refundable and non-cancelable, except cases where Vietjet Air cancel flights due to commercial or operating reasons.
4. Travel Insurance plans can only be changed in conjunction with a Vietjet Air or Valuair Itinerary Change, subject to Vietjet Air's regulations. Chubb will not refund you any premium caused by the possible reduction of your trip duration.
5. Any personal information collected, held (whether contained in this application or otherwise obtained) or provided to Chubb may be held, used and disclosed by Chubb to individuals, service providers and organisations associated with Chubb or any other selected third parties (within or outside of Vietnam, including reinsurance and claims investigation companies and industry associations) for the purpose of processing this application and for providing subsequent service for this and other financial products and services, direct marketing and data matching, and to communicate with Me/Us for such purposes. I/We understand that I/We have the right to obtain access to and to request correction of any personal information held by Chubb concerning Me/Us. Such request may be made at any of Chubb ' Customer Service Centres.
6. I/We warrant that I/We am/are currently in good health, free from physical impairment or deformity and not traveling contrary to the advice of a Medical Practitioner, or for the purpose of obtaining medical treatment. I/We agree that Pre-existing medical conditions are not covered by the insurance.
7. I/We also irrevocably authorise any organisation, institution or individual that has any records or knowledge of Me/Us or My/Our insured family member(s)' health and medical history and any treatment or advice, to disclose such information to Chubb. This authorisation shall bind Me/Us and My/Our insured family member(s), successors and assigns, and remain valid, notwithstanding My/Our or My/Our insured family member(s)' death or incapacity. A copy of this authorisation shall be as valid as the original.
8. Coverage only applies for travel on Vietjet Air flights from Vietnam and is limited within the boundary of the specific country of destination in which the Insured Person disembarks from his/her Vietjet Air flight.
